

Safety: Beating the Heat in Construction

Every year, thousands of workers are affected by heat related illnesses. Along with the higher temperatures of summer comes the higher risk of heat related illness, especially for construction workers. Due to the strenuous nature of the work as well as prolonged exposure to heat and humidity, construction workers are at a higher risk for heat related illnesses.

At Sully-Miller, we experience challenges with our employees having to perform their jobs in high heat environments. This summer, there were multiple high heat warnings issued from the National Weather Service advising us of the excessive high heat conditions throughout Southern California. As the safety department, we understand that our employees are exposed to these types of conditions and recognize the importance of protecting them and providing them with the tools and training that will keep them healthy and safe.

Several actions we have taken this year to ensure the safety of our people include:

- Training our supervisors to recognize the signs and symptoms of heat stress, heat exhaustion and heat stroke as well as taking the appropriate steps if a co-worker does become ill.
- Requiring that all employees have immediate access to water, rest and shade.
- Adding a *Heat Illness* section to our prevention topics in the Daily Pre-Planning form.
- Sending out regular notifications through email and text messages to notify our people of the current and upcoming high heat conditions with specific measures which are to be followed.
- Assigning Heat Illness Prevention training through weekly Toolbox Safety Talks and various Safety meetings.
- Facilitating weekly group conversations during the all-hands construction meetings related to specific project exposures with high heat conditions.
- Ensuring all required safety measures are followed as per the Sully-Miller Heat Illness Prevention policy when the high heat index reaches 95 degrees or higher.

Although heat related illnesses can be life-threatening, they can be prevented or caught in time in order to avoid serious injuries or fatalities by following these safety measures and taking appropriate precautions.

The award qualifies United Rock Products to be considered for the Joe DiShanni Business of the Year Award which will be presented in January 2023.



Sully-Miller Contracting: Driving Seamless Growth

The latest addition in equipment to the Sully-Miller Companies that consists of Sully-Miller Contracting, Blue Diamond

Materials, and United Rock Products includes three new 2021 Peterbilt Super Tag haul trucks. While promoting efficiencies and increasing overall management proficiency, the Logistics and Central Dispatch department will now have an immediate advantage to schedule Sully-Miller drivers and dispatch haul trucks instantly. Over the last month, the performance of this seemingly marginal growth has proven that a minimal difference can make a significant change.

The readily available haul trucks have closed an existing gap within our construction, asphalt, and mining operations. By adding haul trucks to our vertically integrated group, we now have an autonomous capacity to secure the delivery and import of soil, concrete, aggregate blends, grindings, and asphalt for internal and external jobs.

Mike Hill, the Director of Equipment & Logistics, is spearheading the exploration of prospects to enhance our position in one of the fastest growing U.S. markets. Boosted by the Federal Infrastructure package in California, the Sully-Miller Companies are ideally positioned to capture this growth potential and provide a wide range of quality and sustainable products to the customer.



In an industry where time is of the essence, our timing is critical for project bidding, development, and completion here at Sully-Miller

Contracting. For example, when analyzing hauling costs for a conventional *mill and fill* paving jobs, Senior Project Superintendent, Todd Roper, expressed his support for the growth in resources for the Logistics and Central Dispatch and explained the bottom-line contribution to projects costs and productivity.

"For road expansion or rehabilitation jobsites where large milling machines are utilized for removing existing asphalt, our trucks would haul back grindings from the jobsite to the Recycled Asphalt Product (RAP) plant at Blue Diamond, Irwindale and return with a full load of Hot Mix Asphalt (HMA) for overlay back to the jobsite," he explained.

"While strengthening our delivery and hauling capabilities at the same time, the integration of our own hauling trucks is having a sweeping reduction in the administrative cycle becoming more cost-effective than before," said Mike Hill. "In addition to these direct savings from reducing staffing resources placed on the accounts payable and the logistics department, there are also indirect savings that can be quantified as well. Now, we can compare the performance of our trucks to the performance of our sub-haulers working the same route. With our eyes now on the road we can increase driver productivity and improve fleet-wide visibility."

Together, with ongoing internal communication between Sully-Miller drivers, plant contacts, jobsite contacts, the Logistics and Central Dispatch department will be the key driving factor to execute job timeliness that aligns with existing budgets. The addition of these dump trucks is a component of our strategy to further merge our vertically integrated operations designed to work seamlessly together for optimum efficiencies.

Environment Day

On June 9, Sully-Miller employees celebrated Environment Day by planting 60 trees at United Rock Products' Olive Pit, which provides greenery for the pit's neighbors in Irwindale and potential habitat for local critters.

Environment Day is a special day dedicated to raising awareness about biodiversity. Colas first celebrated Environment Day last year by bringing attention to climate issues facing our company and society as well as highlighting Colas' commitment to reduce its carbon footprint. Environment Day will be an annual event for the company to raise awareness and mobilize employees on environmental issues.

What is Biodiversity?

Biodiversity represents all living things and their natural environments, from tiny ocean microbes to majestic mountaintops and everything in between. It is essential to our well-being as goods and services we take for granted may no longer exist were it not for the variety in ecosystems, species, and genetics we have today.

Our human activities generate major pressures on nature and are the main cause of the collapse of biodiversity. 1 million species are threatened with extinction in the coming decades.

Colas has set an ambitious goal of establishing Biodiversity programs at 100% of its quarry sites by 2030!

Project Highlight: LA Outfall

When the Sanitation Districts of Los Angeles County (Sanitation Districts) awarded a \$630 million construction contract for the Clearwater Project to Dragados USA, Inc., we never expected that United Rock Products Inert Fill Operation in Pit 2 would play such a critical part in making this a successful project.

The project will protect local waterways by addressing aging infrastructure, and involves building a new 7-mile long, 18foot diameter tunnel to convey treated water from the Joint Water Pollution Control Plant in Carson to existing ocean outfalls at Royal Palms Beach in San Pedro. Construction began in early 2022 and is scheduled to end in 2026.



The Clearwater Project was approved in 2012 after a multi-year evaluation of the Sanitation Districts' main sewer system, which serves more than 5 million people in Los Angeles County. This planning and environmental review effort included more than 500 public meetings to solicit input and identified the need for a new tunnel to ensure the reliability of the Sanitation Districts' system. The new tunnel will be constructed with a modern tunnel boring machine. This technology has been used throughout the world and extensively for Los Angeles' Metro system. The concern with the process is the west sandy tunnel "mud" to handle and compact, but the crew at Pit 2 was up for the challenge. In order to meet compaction, the crew needs to lay the wet sand in thin lifts and blend it with other drier, more competent import throughout the day.

URP has committed to accepting 536,000 cubic yards of the tunnel mud over the next 3 years from the primary hauling contractor Global Transloading.

"In order to get this to work, we need to place a daily limit on the amount of import and the challenge starts when there is not a sufficient of good fill for blending," said foreman Colton Dickerson as he sees a series of trucks coming from the project.

So, the next time you visit Pit 2, just think about how it is a critical piece of the complex puzzle for completing a muchneeded project for LA County.

Over the past six months our team has made some great additions and reorganized our group to be able to meet the demands of our dynamic market. Together on a foundation of respect, hard work, and competition, the team will do their part to keep Sully-Miller strong into the coming years.

Here is a recap of some of the changes and additions to the Sully-Miller Estimating team:

Estimating Manager: The Sully-Miller leadership team recognized the need to add expertise in alternative delivery as well as support our team and scale best practices as we continue to grow our bid volume. The team added **Rowan Durr** earlier this year to lead this effort and in his short time with us, he has already supported a \$300M Design Build JV pursuit and brought those lessons forward on our current JV pursuit at LAX.

Chief Estimator: **Kevin Ta** rejoined Sully-Miller three years ago and has contributed on many different projects from FD&L's to Oak Hill and everything in between. This year, Kevin was promoted to Chief Estimator of core work and in that capacity, he will be spearheading the effort to identify, review, and secure all paving and reconstruction work for Sully-Miller.

Chief Estimator of Heavy Civil: **Tony Mendez** joined the Colas family last year when he became the Chief Estimator of CCUSA. Earlier this year he also joined the Sully-Miller team as Chief Estimator of Heavy Civil. In his role, Tony will be responsible to set up, oversee, and support the bid close for all Heavy Civil jobs that Sully-Miller pursues in our market.

Project Sponsor/ Business Development: The need to plan for Heavy Civil projects, find partners for Alternative Delivery projects, and maintain a strong presence in the private works market has never been more evident – enter **David Espinoza**. David joined our team last year and has helped us pursue many different projects. His experience and leadership has helped pave the way to many different opportunities and David will continue to identify projects and support our path forward.

New Additions: The estimating team also added some new team members by the way of **Randy Almanza** and **Armando Cisneros**. Randy and Armando bring over 40 years of estimating experience and together will help secure paving and reconstruction jobs throughout Southern California. **Samuel Kirk, Jon King, and Garrett Cheeseman** also joined the estimating team in the past year and have helped support the team by bidding jobs to running bids. They have raised the level of complexity of the jobs we are able to pursue. **Foundation**: The foundation upon which all of this was built is the estimating team that was there when we started this journey almost five years ago. **Jessica Daniels, Maria Ruiz, Jesse Flores, Ray Sanchez, and Randy Quintal** have been the stabilizing force as we continue to expand the types and number of projects we bid.

Together this team will help secure quality work and answer the call as the project demands change and larger opportunities present themselves.

Over the past four years the late summer bidding season has presented Sully-Miller with some exciting bidding opportunities. This year has been no different and I would like to share some highlights of the exciting opportunities coming our way.

Core Work: The outlook is strong when it comes to paving and reconstruction. There has been a steady flow of project opportunities, which is key in core work as inconsistency causes spikes in pricing from vendors, subs, and our competition. We have not seen a dramatic shift in volume from the stimulus program so once that comes to bear it will only add to the opportunities we are already tracking.

Heavy Civil-: There are no shortage of opportunities in the heavy civil market. The team is currently tracking multiple projects and recently, Sully-Miller was successful in the pursuit of Taxiway D, a \$84M best value project where we squeaked out a narrow 2-point win. This was possible by keeping our cost tight, technical proposal strong, and working tirelessly on the interview. The project team knocked it out of the park by securing a 40-point lead on the scoring. Sully-Miller is continuing their path into Heavy Civil by pursuing our first JV on the upcoming LAWA Runway 6L project. Sully-Miller is the managing partner in the Sully-Miller/Skanska Joint Venture and we hope this project not only leads to a successful pursuit but, many more joint venture opportunities.

Private Works: Although interest rates are on the rise and that has slowed some investment dollars, there are still many private developments in our market, one of which is the OCVibe job. Sully-Miller was successfully shortlisted in this exciting opportunity. OCVibe is rumored to be the LA Live of the OC. The new development is planned in the same area as Angel Stadium and the Honda Center. LA Live is across the Staples Center which is an exciting project that Sully-Miller helped build many years ago.

Project Highlight: Ranchero Road Corridor Widening Project for City of Hesperia

The Ranchero Road Widening Project is a \$37.9 million dollar contract that will demolish the existing bridge over the Department of Water Resources Aqueduct and construct a new bridge, all to be self-performed by Sully-Miller. The work also includes removal of existing drainage culverts to be replaced with new reinforced concrete box culverts, widening of the Union Pacific Railroad Crossing, and signalization of three intersections. The project was bid September 21, 2021 and work began April 25, 2022.

Major quantities of work for the project include 2.8 miles (15,000 lineal feet) of water pipeline installation and replacement of water services, 100,000 cubic yards of roadway excavation, 62,000 cubic yards of aggregate base, 73,000 tons of hot mix asphalt paving, and 31,000 tons of rubberized hot mix asphalt to be paved from the Blue Diamond asphalt plant in Victorville, CA.

The project is the third phase to enhance the Ranchero Road Corridor, a major east-west corridor carrying more than 15,000 motorists daily.

The objective of this project is to enhance the five mile-corridor of Ranchero Road between the underpass and interchange, reduce roadway congestion, accommodate an increase in travel, and reduce response times for emergency vehicles.

Major enhancements include:

- Widening Ranchero Road to accommodate two lanes in each direction and a center striped median
- Demolishing the existing bridge and constructing a new bridge at the California DWR aqueduct
- Widening the at-grade crossing at the UPRR railroad tracks
- Replacing corrugated metal pipe drainage crossings with concrete reinforced box culverts and add one new box culvert
- Various utility relocations

Blue Diamond Completes Large Project for Amazon Distribution Center

Blue Diamond Materials was selected as the supplier of choice by Peterson Grading and Paving to supply hot mix asphalt and crushed miscellaneous base for a large Amazon distribution center in the high desert.

This project involved supplying 54,000 tons of CMB for the aggregate base course followed by 49,000 tons of HMA. In addition to the massive parking area for the Amazon delivery trucks, it involved building a four-lane entry road that was $1 \frac{1}{2}$ miles long.

We began the supply in spring of this year with Phase I and completed the final phase in September.

The project went very well, with high praises for great service and excellent product quality from the Estimator and Paving Foreman.

I would like to extend a personal thanks to the Sales and Logistics team, and the great team at Blue Diamond Victorville that completed this project so successfully. And we got it done before Prime Day!


Project Update: Wilmington Waterfront

The Wilmington Waterfront Project is quickly approaching its completion date. Construction is expected to be complete by March 2023, but still has a lot to be completed. With all major underground utilities and the majority of the water work complete, the project will begin to enter the final phase with all the finishing touches.

The new restroom building has the outer shell complete and is awaiting construction of the roof portion, which will also serve as a green roof. Once that is complete, the pathways that tie in can be completed. Items left to install include 50,000 SF of pavers, another 1,000 CY of colored concrete and 1,500 LF of marine railing. The Wilmington project started in December 2020 and has, for the most part, gone according to plan with the exception of some third-party utility delays.

To date, the job has brought in over 60,000 CY of clean dirt, installed 42 pre-cast concrete piles in the water for a new pier structure, and installed 400 LF of steel king piles and sheet piles that will serve as the foundation for a new sea wall that is currently being constructed. The biggest challenges so far have been dealing with the tides for all the water work and the dewatering we had to do for the deep utilities. We dewatered over a million gallons of water on the project.


