# Standard Operating Procedure for Inert Fill Import into United Rock Products 1245 Arrow Hwy, Irwindale, CA 91706

## **Acceptable Materials:**

- Clean Soil
  - ALL INBOUND SOIL MUST HAVE A LABORATORY REPORT, ADDRESS OR GPS COORDINATES WHERE THE SOIL ORIGINATED FROM, AND A SATELLITE IMAGE OF THE AREA (WITH SAMPLE LOCATIONS MARKED) SENT TO alma.cortez@sully-miller.com
  - **PLEASE ALLOW 48 HOUR** turnaround for soil analytic review by the Environmental Dept.
- Broken Concrete (Brick Allowed)
  - Must be dry & have a minimal quantity of fines in the load (i.e. less than 5%).
  - Wet loads may be rejected and turned away at the gate.
  - A laboratory report will be required if a concrete load contains more than 10% soil. Otherwise, the load will be rejected and turned away at the gate.
- ➢ NO ORGANICS AND NO TRASH.
- > THERE IS **ZERO TOLERANCE** FOR ASPHALT IN ANY CONCRETE OR CLEAN SOIL LOADS.

## **Soil Testing Requirements:**

- Two (2) soil samples is required for all jobs (up to a max volume of 5,000 CY). Additional samples will be required for larger volumes.
- A Google Earth or satellite image is required for all jobs. Limits of excavation and sample locations must be clearly marked and identified.

## **Required Tests:**

- Volatile Organic Compounds (VOC) EPA 8260B
- Gasoline/Diesel/Oil Range Organics (C4-C40) EPA 8015B
- California Title 22 Metals EPA 6010B
- Mercury EPA 7470/7471
- Additional tests may be required based on the history/previous use of the site.

## Once Soils have been Tested

Contact Sales Manager and provide the following information:

- Volume (in cubic yards)
- Type of Material
- Laboratory Report
- Satellite Image
- Phase I/II Environmental Site Assessment (ESA) Report / Geotechnical Soils Report\*
  - \* A physical address & Google Earth or satellite image is required for the location of the materials (i.e. where the soil came from, not where the soil is stockpiled/held).

## **Once Soils Tests have been Approved**

Confirm with Sales Manager that an ORDER # at United Rock has been created before hauling.

- Any material hauled to United Rock prior to confirmation will be rejected and turned away at the gate.
- Please schedule via QR CODE sent by Sales Management.
  - EACH INBOUND SOIL LOAD WILL NEED A DUMP SLIP WITH THE CUSTOMER NAME / DATE / ORDER # / JOB NAME PROVIDED BY THE CUSTOMER TO HAND TO THE SCALE CLERK.

#### Soils should be tested at a laboratory for the following items:

- Volatile Organic Compounds (VOC) EPA 8260B
- Gasoline/Diesel/Oil Range Organics (C4-C40) EPA 8015B
- California Title 22 Metals EPA 6010B
- Mercury EPA 7470/7471
- > A minimum of two (2) soil samples is required for all jobs (up to a max volume of 5,000 CY).
- > Additional samples will be required for larger volumes.
- > Additional tests may be required based on the history/previous use of the site.
